e-mail: Tina.Antonsen@skynet.be, hereafter represented by **Tina Antonsen**, affiliated to "Beroepsinstituut voor vastgoedmakelaars" (BIV 105 236), hereafter named "**broker**".

It has been agreed as follows:

1.The principal mandates the broker to find a tenant **for a:**

FURNISHED / UNFURNISHED – APARTMENT / HOUSE – NUMBER OF BEDROOMS: PARKING YES/NO

2.The **rental price** set by the principal for the property shall be €..... /month.

Parking space €..... /month, **listed costs** €...../m: (**Total rental price** = €...../m) 0 flat fee for heating and electricity up to €..... (any proven consumption above this amount shall be borne by the tenant)

0 Cold and hot water, general management costs of the building

0 Television connection (standard connection of 35 channels, for more channels, the tenant has to pay extra)

0 Internet connection (standard connection for 2PCs, for higher or faster consumption, the tenant has to pay extra)

0 Cleaning (**included in the rent / not provided / extra charge = €...../month**)

0 Extra parking space (**included in the rent / not provided / extra charge = €...../month**)

0 Inventory of fixtures to be drawn up by the owner himself.

0 For the inventory of fixtures, the owner appoints the following expert:

0 EPC (Energy Performance Certificate) (handed over / not handed over / wishes to make an appointment

3. The present agreement shall have a **term** of six months from today. Then it shall be terminated by operation of law if the principal so informs by registered letter; otherwise it will be tacitly renewed.

4. If a **rental deal is made** with a person/company/relocator that was proposed to the principal by the broker, the fee shall be **10% of the total rental price (i.e. rent + charges + 21% VAT)** with a required **minimum amount of € 450.00 (+21% VAT)**.

This brokerage commission shall be due upon signature of the lease. If the rental period is renewed by the same tenant who was introduced by A Cosy House, a fee will again be owed for the duration of the agreed rental period with a maximum of one year. Additionally, in the event of **breach** of this rental order or **own rental** of the property, a minimum amount of €450.00 (+21%VAT) shall be due.

5. This agreement is **exclusive / non-exclusive** (with other brokers:

6. The broker shall conduct, at his expense, any **publicity activity** he deems necessary.

A poster or publicity sign **may** be affixed to the property / **rather not**.

7. In the event of rental within six months **after the end of this order** to one of the customers proposed by the broker, the principal shall owe the broker a fee equal to the fee set specified in article 4.

8. Any dispute regarding this agreement shall be submitted to the exclusive jurisdiction of the Antwerp courts.
